**Optional modules. If doing 9 months anaesthesia, optional modules should be completed. Paediatrics is not mandatory, but completion is desirable. If unable to complete, then to inform TPD to ensure paedics can be completed in CT3/ST3. All trainees will require paediatric competencies in Core Training to be address in years 2 or 3. Child protection must be completed by all trainees.
